1. Two (2) pieces. CSC passport size picture (80% of picture is occupied by the face) with hand written name tag and signature affixed prior to having photograph taken.
 - Signature must be on top of printed name
 - The photograph should have been taken within three (3) months prior to filing or request.
 - One (1) valid identification card

- Two (2) valid identification card of the eligible (if request is filed through a representative)
2. Additional Requirement for representatives
- One (1) valid identification card; and
 - Authorization letter or Special Power of Attorney (SPA)
